Please contact Mr. Berg if credit card payment is needed. The registration fee is good for 12 months. Once class fee is paid it is non refundable.
2. I acknowledge there are no refunds for missed classes unless the instructor cancels the class.
3. If I need to cancel a private class, I agree to call or text Susan (316-288-9374) with 24-hour notice or recognize I will forfeit the class fee.
4. I agree to be prepared for class by wearing the proper attire and shoes. This includes not wearing street shoes (anything worn outside) on the dance floor. I understand dance shoes, socks or shoe covers are acceptable.
